**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

**Applicability.** Form HUD-50075-ST is to be completed annually by **STANDARD PHAs** or **TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

families, including publishing public notice of such availability in a newspaper of general circulation in the jurisdiction at least thirty days before offering the unit to an over-income family; (3) The over-income family rents the unit on a month-to-month basis for a rent that is not less than the PHA's cost to operate the unit; (4) The lease to the over-income family provides that the family agrees to vacate the unit when needed for rental to an eligible family; and (5) The PHA gives the over-income family at least thirty days notice to vacate the unit when the unit is needed for rental to an eligible family. The PHA may incorporate information on occupancy by over-income families into its PHA Plan statement of deconcentration and other policies that govern eligibility, selection, and admissions. No.

Will the apt. sizes increase?

Yet to be determined.

Will there be any improvements to non-dwelling areas of the building, such as storage, security, etc.?

Very likely yes.

Can people who live in the building just have their Section 8 if they do not to be part of the RAD conversion?

Choice mobility vouchers will be available after 1 year if we convert through PBV, which is the current application.

Is the subsidy comparable for to what people would get on Section 8-budget and subsidy the same?

Rent portion is determined based on 30% of income, same as current PH program.

Does AH need more repair than WW? Is it safe to say that AH will be torn down?

We believe AH will require more extensive work, if not demolition and reconstruction. A capital needs assessment will determine the extent of work to be done.

Will we send out a letter or notification to let residents know if the RAD application was accepted?

We will update residents in numerous ways, at resident meetings, RAB meetings, FHC board meetings, on the website, flyers, etc.

Will the townhouses be attached to others or scattered?

If we construct townhomes they will likely be 2 or more units connected. It will depend on building and zoning codes and requirements.

Will residents be able to purchase their home?

We hope some form of homeownership option/program will be used if we sell some of the scattered site homes but that is separate from the RAD process.

Will the families in the scattered sites be cut down in terms of their family members in order to fit in smaller units?

The number of people in a household determine unit size (2 people per bedroom) and there are some exceptions like through reasonable accommodation, where additional bedrooms are required.

Will there be more kids at Autumn House?

There will likely be more 2-bedroom units at AH. The configuration of the families is unknown, but children may be more prevalent.

How long does S8 last for? Is it an infinity program?

S8 is a federally funded program subject to annual appropriations.

Do we need to have a certain number of RAB meetings?

One.

What if the landlord doesn't fix things?

S8 has annual inspections and on-demand inspections if there is something wrong. Properties must meet S8 HQS inspection standards.

If someone ports can they come back?

S8 provide portability and we do accept ports into our program.

PBV is 1 year, PBRA is 2 years.

How are developers involved in the process right now?

There is an RFQ out to find a potential partner.

PH see Emily; HCV see case worker.

How often can you move on S8?

Usually once per year, exceptions occur (VAWA, HQS fail, etc.)
