### E. Approval of Disbursements

Review of invoices completed by Sutherland

Bentley requested that staff review 708 Gardendale. Is this a 4 bedroom home, and why bill so high?

Bentley asked about the Blue Care Network invoice description of "diagnostic fee." Van Poucker explained this was a clerical error and confirmed that BCN credited our premium that amount. Bentley asked about the invoice description "resident watch" listed for First Advantage. Van Poucker explained this company completes our annual resident background checks that are completed as part of the recertification process.

Van Poucker explained the reason for the decline in HAP, that the shortfall in late 2017 required that we stop leasing. We could not begin leasing again until March/April at the earliest however we were preparing to open our waiting list. We should see a rebound in units leased and HAP issued in coming months.

Van Poucker noted a slight spike on payroll due to payout of terminated employees unused accrued time at separation.

Motion by Commissioner Davis, seconded by Johnson, be it resolved to approve the Disbursements as presented.

RAD update – RFQ for developer consultant/partner is issued. Social Worker started work, attended resident meetings, will have office hours. Next steps, RAB, select partner, capital needs assessment, implement communications plan, plan field trip.

Johnson suggested a direct invitation to the scattered sites for RAB.
