6. Executive Director's Report

Heather Van Poucker reported on pest control, lease violations, occupancy, delinquencies, and work orders. City inspections were completed in early December. In addition to carbon monoxide detectors already placed near furnace units, additional detectors were added to sleeping areas of scattered site homes in compliance with new HUD mandates.

The FHC policy review plan suggests a review every five years of the Public Housing Admissions and Continued Occupancy Policy (ACOP) and the HCV Administrative Plan which will occur in 2023. Any substantive changes to the ACOP will require an update to the FHC Resident Handbook.

FHC is on course to enter into an AHAP with Full Circle to provide 8 project-based vouchers to their development at Sheppard House.

Fifteen residents and staff members attended a full-day Mental Health First Aide training event on December 15th.
