- Rolling 5-year Plan for 2023 and 2024 was submitted and approved
- Revisions to HCV procedures to be added to Admin Plan
- Disciplinary and Grievance procedures were implemented and will be added to the Admin Plan.
- AH restoration updates were explained, the restoration will begin soon.
- Hot water tank repaired at AH

#### 7. Old Business

- Damaged units and relocations were updated with units being under repair and the two affected families permanently relocated, one to WW and the other to Scattered Sites
- Asbestos report was updated with air quality analysis which showed safe air quality at AH.
- PIC submissions were resumed. PIC reports are linked to PH funding and had not been updated since October 2023 and are now current.
- The landscaping updates were provided. Both buildings have benefit from professional landscaping

#### 8. Call to Audience

- Several residents were concerned that they had not been given enough time to prepare for bedbug inspections. (More time to prepare will be given)
- Gwen Hough welcomes the bedbug inspections and the efforts
  FHC has committed to in eliminating the pests.
- A concern regarding the wallpaper sloughing off the wall near apt.
  408 (Restoration Pros were awaiting approval from FHC insurance, the insurance agent was contacted to expedite repairs)
- Deborah Diggs inquired into her DTE bill with concerns the fans used to dry her apt. during the roof issue had increased her bill (Kimmaly Morris has the bills and is reviewing them all for charges caused by the fans)
- Several residents complained of rats around the building (rat baits have been placed around both buildings inside and out)
